No public celebration of Ganesh Chaturthi in TN

CHENNAI: Tamil Nadu Chief Minister MK Stalin on Tuesday said the state government has banned celebration of religious festivals in public places including Vinayak Chaturthi to prevent the spread of Covid-19. In response to a point raised by BIP lawmaker Nainar Nagendran in the Assembly, Stalin said the Covid-19 infection increased in Kerala as they had permitted gathering of people in large numbers during Bakrid and Onam. The Covid-19 pandemic in Tamil Nadu is not completely over and that is why till September 15 all religious celebrations in public places have been banned.

Kerala to withdraw night curfew, Sunday lockdown

THIRUVANANTHAPURAM: Kerala Chief Minister Pinarayi Vijayan on Tuesday said that it has been decided to do away with the night curfew and Sunday lockdown restrictions in the state. The CM, in a press meet, said the decision to withdraw the Sunday lockdown and night curfew was taken during the Covid review meeting. After daily cases rose to more than 30,000 after the Onam celebrations, the state had brought in night curfew from 10pm to 6am from Monday to Saturday to check the increasing numbers.

K'taka govt will spare no effort in implementing NEP

MYSURU: The Karnataka government will spare no effort in the next 20 months for the implementation of National Education Policy (NEP-2020), Minister of Higher Education, CN Ashwath Narayan, said on Tuesday. While inaugurating a seminar on NEP jointly organised by the Maharani Women's Science College (autonomous), Maharani Arts College, and Maharani Women's Commerce and Management College, the minister said that NEP aspires to empower students by grooming them to become globally competitive. The Union government has set a timeline of 15 years for the implementation of NEP.

Shah to address Liberation Day event on Sept 17

HYDERABAD: Union home minister Amit Shah will visit Telangana on September 17 to attend a public meeting in Nirmal district to coincide with the Telangana Liberation Day. BJP leader and party MP from Adilabad, Soyam Bapu Rao, said on Tuesday that Shah will address meeting at Veyi Udala Marri. BJP is making elaborate arrangements for the public meeting. State BIP president Bandi Sanjay will stop his ongoing 'padyatra' for a day to attend the public meeting. The meeting is also being seen as part of BJP's campaign for ensuing elections to the Huzurabad Assembly seat.

TN health minister seeks 1 crore vax doses from Centre

CHENNAI: Tamil Nadu Health Minister Ma Subramanian has written to Union Health Minister Mansukh Mandaviya seeking I crore Covid vaccine doses in a single lot for the state to vaccinate 20 lakh people at 10,000 vaccination camps to be organised on September 12. In the letter, Subramanian has requested the Union Health Minister to provide a special quota of I crore vaccine doses to inoculate all those above 18 years of age with at least the first shot of the vaccine.

Make farm laws report public, writes panel member to CJI

A member of the Supreme Court-appointed panel on farm laws has written to Chief Justice of India NV Ramana, seeking that a report submitted on the issue be made public. The panel had submitted its report in March this year. "I feel that the report has not been given any attention by the Hon'ble Supreme Court," wrote Anil Ghanwat, who was nominated to represent the farming community in the committee.

Ghanwat's letter comes amid an escalation of the long agitation by farmers following police violence on a group of protesters in Haryana's Karnal.

Case against babu over inappropriate WhatsApp

Kerala police on Tuesday registered a case against IAS officer N Prasanth for allegedly insulting the modesty of a woman journalist According to High Court by sending her inappropriate stickers over WhatsApp while she reached out to him for an official reaction.

Police told PTI that a case has been registered in the incident, which happened in February this year after obtaining legal advice on the issue. "We have registered a case under Section 509 of the Indian Penal Code," police said. Prasanth, the managing director of Kerala State Inland Navigation Corporation, was caught in a political controversy early this year after the corporation signed an MoU with a US firm on deep sea trawling.

UP POLLS: MAYAWATI CALLS FOR DALIT-BRAHMIN UNITY

LUCKNOW

Accusing the BJP and the Samajwadi Party of only making tall claims but doing nothing on the ground, Bahujan Samaj Party (BSP) president Mayawati on Tuesday gave a clarion call for a "Dalit-Brahmin" unity to bring her party back to power in the state.

Addressing a "Prabudh Varga Sammelan" at the end of the party's month-long programme to reach out to upper caste Brahmins across the state, Mayawati said both the



BJP and the SP indulged in empty talks to win the votes of Dalits and Brahmins, but neither safeguarded their inter-

ests when in power. Unlike them, the BSP stands firm on its "Kathni aur karni (words and deeds)", and this could be testified from its rule in Uttar Pradesh from 2007 to 2012, when security and welfare of Dalits and Brahmins, along with other sections of the society, were given top priority, she said.

The BSP chief also took potshots at the Congress for communal riots in Meerut and Muzaffarnagar when it was in power at the Centre and blamed the party for not giving protection to the minorities.

Sidelined, 'PRODIGAL' Tej floats parallel body

PATNA: Sidelined in the RJD, founded and headed by his father Lalu Prasad, elder son Tej Pratap Yadav has floated a new students' body with the ostensible aim of strengthening the parent organisation.

Yadav launched the Chhatra Janshakti Parishad two days ago and claimed that it was not meant to pose anv challenge to the Chhatra RJD, the party's official student wing, but work towards "mobilizing youth at the village level".

The maverick MLA came out with the announcement, claiming, as always, that he had "the blessings of Lalu Prasad", at a time when he was left licking his wounds after losing the battle in a tug of war with state RJD chief Jagadanand Singh.

Singh, known to be close to Yadav's younger and more powerful sibling Tejashwi Yadav, had earned the wrath of the mercurial elder brother recently when he sacked Akash Yaday as the state president of Chhatra RJD.

Though there was no official word on the reasons behind the removal of Akash Yadav, one of the few close
